MESSAGE FROM THE EXECUTIVE DIRECTOR

I have given literally hours of thought about the message I wanted to share this year in my AGM Report. I have agonized about how to sum up this fiscal year in a way that has meaning, has reflected our reality, has acknowledged all the contributions of clients, staff, the board, and the community and recognizes the many social injustices that have plagued us amid a pandemic.

COVID-19 has dramatically altered life for everyone, but what it has not done is reduce the incidence of Violence Against Women, in fact it has exacerbated it. Isolation has always been an abusive tactic and we have found ourselves in a situation where isolation has been globally sanctioned. Throughout this pandemic, women and their children have been more at risk than ever before. I anticipate that we will all be dealing with the consequences, both good and bad of this pandemic for years to come. We have all found ourselves in the same storm, the difference is some of our vessels are more storm worthy than others.

We began the fiscal year in lockdown and ended the fiscal year in lockdown, certainly not something we expected, were prepared for, or knew how to manage...but we did it!

I want to acknowledge our many brave partners on this journey:

- Our clients, they have faced such uncertainty, such fear both of their abuser and of COVID, do you take the risk of leaving or the risk of contracting COVID in an environment you are unsure of, a decision that no one should be faced with. The women we serve have been resilient, courageous and above all else our allies in the fight to stay safe from their abusers and stay safe from COVID.
- Our staff, on many occasions I have said to them I feel like I won the staff lottery and never has that been truer than this past year. These women have given their all, their passion for their work, their commitment to their clients and their flexibility and adaptability has been second to none. Each of these women have balanced their personal lives, their COVID fears and have still made the women we serve a priority. My genuine and heartfelt thanks to the management team, Sue Ann, Kelly and Vanessa, I could not have done this without you.
- Our board, these folks have done extraordinary work in providing governance and support to both me and the staff. Their concern for both clients and staff has been a priority throughout the year. They have been vigilant in making sure we have had everything we need to navigate these rough waters. Thank you to Michelle Becker for leading this board in one of the most difficult years of our existence, as the expression goes initiation by fire.


